Water Pollution Prevention & Control Law	Requirements for wastewater prevention and treatment	Effective in 2018



- Deepening pollution prevention and control in key basins and establish function zoning management system.
- guarantee safe sources of drinking water
- treating black and odorous water bodies in cities
- Treating water pollution in industrial agglomeration areas on a centralized basis
- Boosting prevention and control of agricultural and rural pollution
- strengthening wetland protection and restoration
- to improve environmental supervision and law enforcement mechanism, develop Environmental Protection Inspection once more.
