Role of WASA

- ◆ **WASA is designated as the urban water supply sector regulator responsible for making sure that water suppliers provide their customers with a good-quality, efficient service at a fair price.**
- ◆ **The mandated role and responsibilities of WASA are set out in the Prime Minister's Decree 191/PM (1 July 2005) on *Regulation of Urban Water Supply Operations*.**

What's WASA do?

- **Assisting the provincial authorities in issuing licences to suppliers**
- **Ensuring that suppliers carry out their responsibilities as set out in their licences, legislation and regulations**
- **Undertaking independent tariff reviews and presenting recommendations to the provincial authorities**
- **Protecting the standard of service customers receive through ensuring compliance with regulations and, where appropriate resolving disputes between suppliers and their customers**
- **Encouraging suppliers to become more efficient through comparative competition and the publication of regular performance reports**
- **Ensuring that suppliers act responsibly towards the environment**
- **Encouraging competition in the sector where appropriate**

and WASA's not do

- We do not have any jurisdiction over rural water supplies. This is the responsibility of Nam Saat under the jurisdiction of the Ministry of Health.
- WASA is not responsible for urban water supply sector policy, planning and development. The Water Supply Division of the Department of Housing and Urban Planning undertakes these activities. Similarly, WASA is not responsible for the day-to-day management of water suppliers.
- WASA is not responsible for the protection of the environment as this is a direct responsibility of the Water Resource and Environmental Authority and various departments within the Ministry of Agriculture and Forestry
