### FY2011 Focus of Action

(April 2011-March 2012)

Considering that key international water meetings such as the second Asia-Pacific Water Forum and the sixth World Water Forum will be held in FY2011, WEPA will focus on the following activities

- Prepare and distribute "outputs" of WEPA discussion in the second phase to date (to make outputs, surveys and workshops to wrap up the discussion at WEPA meetings);
- 2) Disseminate WEPA message to the world. The message will address challenges of water environmental management in WEPA partner countries identified through the WEPA discussions;
- 3) Draft a new version of "WEPA Outlook of Water Environmental Strategies" of which first version was prepared for the fifth World Water Forum.

#### **WEPA International Workshop**

#### 1. Objectives:

- (1) Revisit the issues discussed under WEPA in the second phase (progress of water environmental management; domestic wastewater treatment; climate change and the water environment) and other related area (e.g. water environmental management at basin level) and identify challenges and opportunities.
- (2) Based on (1), develop WEPA Message for promotion of water environmental management in Asia.
- (3) Incorporate findings of (1) and (2) into the WEPA Outlook (publication).

#### 2. Expected participants

About 50 participants including not only representatives of WEPA partners but also other stakeholders such from University, NGOs

#### 3. Others

Possible collaboration with other initiatives/organizations such as NARBO will be sought out

#### **Collaboration with NARBO**

- 1. Cooperation to the Water Quality Workshop to be organized by NARBO (e.g. sending a resource person, participation in the discussion) Details will be discussed with the NARBO Secretariat in due course.
- 2. Asking participation of NARBO Secretariat (and some of NARBO members) in the WEPA workshop. If there are any common agenda of NARBO and WEPA, more proactive collaboration (such as joint session in the WEPA workshop) will be considered.
- 3. Where possible, joint events or exhibition at international meetings such as APWF.

#### **WEPA Dialogue**

- 1. WEPA dialogue aims to discuss the way to improve water environmental management in the host country and Japan through exchange information and ideas.
- 2. It is to be decided where the 2011 Dialogue will be held.

- Situation Analysis of water environmental management in WEPA countries

#### WEPA Outlook on Water Environmental Strategies (1) – Country Information

- Country Information = 4 pages/country (easy to read for policy makers)
- Country information will be drafted by WEPA Secretariat based on the WEPA database and 6<sup>th</sup> Annual Meeting and ask additional inputs/review of focal point of each country.
